IDPROTECT® – identity theft monitoring and resolution service¹ for you and your joint account owners

- Up to \$10,000 Identity Theft Expense Reimbursement Coverage² – To cover expenses associated with restoring your identity.
- Fully Managed Identity Theft Resolution Services – Access to a dedicated fraud specialist assigned to manage your case until your identity is restored.
- Credit File Monitoring – Daily credit file monitoring and automated alerts of key changes to your credit report. (registration/activation required)
- Credit Report – Ability to request a single bureau credit report every six months or upon opening a resolution case. (registration/activation required)
- Credit Score³ – Ability to request a single bureau score every month. (registration/activation required)
- Credit Score Tracker – Receive valuable insight into your credit score^{3,4}
- Identity Monitoring – Monitoring of over 1,000 databases. (registration/activation required)
- CyberRecover™ – 24/7 access to personal cyber advocates who provide support and guidance to help navigate and mitigate the impact of hacking and other cyber incidents.
- Financial Wellness 360° – Financial wellness platform with tools and resources to help employees improve and maintain financial wellness (available via mobile or web only).

Telehealth⁵ – Access to 24/7 video or phone visits with U.S.-based board-certified, licensed and credentialed doctors ready to help with physical and mental health care. There are zero copays, plus discounts on prescriptions and lab work. (registration/activation required)

TIGER REWARDS CHECKING ACCOUNTS have a monthly account fee of \$6, but it will be waived provided you maintain a \$2,500 average daily balance. Alternatively, you can earn a \$2 monthly credit for each of the following:

- RECEIVE E-STATEMENTS
- MONTHLY DIRECT DEPOSIT
- MAKE 25 DEBIT CARD PURCHASES PER MONTH

³ Credit Score is a VantageScore 3.0 based on single bureau data. Third parties may use a different VantageScore or a different type of credit score to assess your creditworthiness. Once you have activated credit file monitoring, you may request your credit score. Once you have done so, you will have access to your score on a monthly basis.

⁴ Credit Score Tracker: Once credit file monitoring has been activated and you have requested your first credit score, you may request a new credit score each month to be plotted on your Credit Score Tracker graph. Monthly email notifications will be sent to let you know when your new score is available.
